**PLAYER WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT
PLEASANTON PARKS AND COMMUNITY SERVICES**

I, the undersigned player, acknowledge, agree and understand that:

1. Voluntarily and of my own free will, I elect to participate as a member of the softball team and league indicated above.
2. I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players, including, but not limited to those hazards associated with weather conditions, playing conditions, equipment and other participants.
3. I understand that sliding into base is dangerous to me and to other players and may result in serious injury or death.
4. I understand that the very nature of the game of softball is hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding and catching the ball, the swinging of the bat, running, jumping, stretching, sliding, diving and collisions with other players and stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I the undersigned agree that in consideration for the right to play as a member of the team designated above and in consideration for permission to play on the field arranged for by the team or league:

1. I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or league for practice or play.
2. I release, discharge and agree not to sue the team and league designated above, City of Pleasanton, the Softball Association, or their owners, officers, agents, servants, associations, employees or any other person or entity connected with the team, league, field or Softball Association for any claim, damages, costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.

I ACKNOWLEDGE THAT I HAVE READ AND THAT I UNDERSTAND EACH AND EVERY ONE OF THE PROVISIONS IN THIS WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AND AGREE TO ABIDE BY THEM.

Players' Contract

Each individual must read the players' contract before signing his/her signature on the roster. Names of individuals on the roster that have not signed their signature will not be eligible to participate in the league.

By affixing my signature to the team roster, I have read, understand and agree with the statements set forth in paragraphs 1 through 7 of this page.

1. **Release (injury to myself or to my personal property).** That I release the City of Pleasanton, its Council, Commissions, officials, agents, and employees for any injury to myself, or for my death, or for property damage on behalf of myself, or my heirs or successors in interest, arising from my participation in the league/tournament conducted by the City of Pleasanton.
2. **Hold Harmless (injury to others or other property).** That I will indemnify and hold harmless the City of Pleasanton, its Council, Commissions, officials, agents, and employees from any loss or liability (bodily injuries or death, and/or damage to property, including the loss of use thereof) which results or is alleged to have resulted from my participation in the adult leagues/tournaments conducted by the City of Pleasanton.
3. **Player responsibility for Procuring Insurance.** That I am fully aware that the City of Pleasanton carries no medical insurance for any participant and that I am solely responsible for securing my own insurance, and that my team is responsible for securing its own insurance.
4. **Manager Familiarity with Rules.** My manager has advised me the he/she has read the rules issued by the City of Pleasanton and has advised me of the contents thereof.
5. **Assumption of Risk.** That I assume all risks involved in my participation in the league or tournament and that I recognize that I am solely responsible for my decision to participate in any game in the league/tournament, and that the above release stated in Section 1 includes, but is not limited to, a release (1) for maintenance or condition of the playing area; (2) for condition of appurtenances thereto (courts, bleachers, fields and gyms); and (3) for equipment supplied by the City of Pleasanton.
6. **Sports Skills.** That I am familiar with the skills required to participate in the league or tournament conducted by the City of Pleasanton, and have satisfied myself that I am proficient in these skills and that the above stated release in Section 1 includes, but is not limited to, a release for failure of the City of Pleasanton to provide classes for the technical instruction therein.
7. I recognize the strenuous aspect of this sport and that it involves running, jumping, and possible physical contact. I hereby attest that I am physically capable of participating in this activity.

Managers' Contract

I hereby agree that I will manage my team in accordance with high standards of sportsmanship and require players recognize my authority for control of the team on the field and surrounding areas. Further, I understand that any player who has not signed the official roster or a Roster Add/Drop form is not eligible to participate in this league/tournament. I have read, understand and explained the rules under which this league/tournament will be played to my players.
