



Description of Picnic Sites

1. Amador Valley Community Park

4301 Black Avenue (behind the Aquatic Center)
Capacity: 200

Includes 20 picnic tables, individual and group barbecues, and is adjacent to a children's play area, restrooms, field area with backstop, horseshoe pits, and flat turf area. The softball field is available on a first-come, first served basis.

2. Pleasanton Sports and Recreation Park

5800 Parkside Drive
Capacity: 200

Located next to the adult softball complex, includes 20 picnic tables, individual and group barbecues, and is adjacent to a youth play area, restrooms, and sports fields. The sports fields are available by separate reservation only. Please call 931-3437 for availability.

3. Val Vista Community Park

7350 Johnson Drive
Capacity: 250

Large group picnic area with 25 tables at the south end of the park, is located next to a large playground with water elements, a climbing wall, and restrooms. Other park amenities include: in-line skating arena, roller hockey rink, labyrinth, and three soccer fields.

- Pleasanton residents may reserve a picnic area up to one (1) year in advance.
- Businesses or nonresidents may reserve a picnic area up to six (6) months in advance.

Applications will not be considered if submitted less than two (2) weeks prior to the event date.

Reservations will only be confirmed upon submission of a completed, signed application and payment of appropriate fees.

A nonrefundable \$50 Reservation Deposit is required at time of application.

Payments may be made by cash, check, or credit card (Visa or MasterCard only).

Cancellation Policy

Applicants finding it necessary to cancel reservations must do so in writing 30 days prior to the date reserved, and will incur a cancellation fee of \$50. There are no refunds for rain, although you can reschedule a date (due to inclement weather) prior to your reservation date.

Damage/Compliance Deposit
A \$100 damage deposit is required for all picnic reservations.

This deposit is refundable after your rental if the picnic site is left in satisfactory condition, and all trash is disposed of properly. Deposit fees will be refunded in the same form as payment, in approximately three (3) weeks.

Insurance Requirements

Applicant **may** be required to provide the City of Pleasanton with a valid Certificate of Liability Insurance. Such Certificate shall provide Bodily Injury and Property Damage Liability protection at a limit of \$500,000. The Certificate shall name the City of Pleasanton as an Additional Insured in conformance with the Hold Harmless Agreement.

Hours of Park Use

Pleasanton parks are open from dawn until dusk.

Rental Fees

Priority A - Cosponsored Groups

Cosponsored classification is reserved for community groups that serve a significant number of residents, provide a wholesome and desirable recreational activity, and are considered of service to the Pleasanton community.

All cosponsored groups are designated by meeting the requirements included in the Policy for Recreation Group Sponsorship Classification.

To be considered for co-sponsorship, an organization must file a formal application.

Priority B – Pleasanton Resident

Must reside within the Pleasanton property tax limits, and provide proof of residency at time of reservation.

Local organizations must provide membership lists showing 75% of members residing within the Pleasanton property tax limits in order to qualify for resident status.

Priority C – Nonresidents

Applicants residing outside the City limits of Pleasanton.

Organizations whose memberships are less than 75% Pleasanton residents.

Priority D – Commercial, For-Profit Organizations –

Use of City facilities for business purposes.

Park Rules and Restrictions

- Alcoholic beverages are not allowed in Pleasanton parks.
- Inflatable jump equipment (for children), ponies or dunk tanks are not allowed in any City park.
- Barbecues are provided in picnic areas. No portable barbecues are allowed in picnic areas. Coals and ashes are *not* to be dumped in trash receptacles.
- Any decorations must be properly disposed of prior to leaving the picnic area.
- Signage, posters, or banners may not be attached to any park structures, including walls, trash receptacles, columns, trees, and light posts. All signs must comply with City sign ordinance.
- Dogs are to be restrained by a substantial leash not to exceed six feet in length. Persons with dogs must dispose of waste immediately.
- No amplified music is allowed in parks without written approval from the Director of Parks and Community Services.
- No advertising shall be exhibited and no solicitation or sales made on the grounds of any park without written permission from the Director of Parks & Community Services.
- No vehicles are to be driven or parked on walkways, patios, or turf areas. Deposits will be forfeited for noncompliance.
- Bring your authorized Picnic Area Agreement with you on the day of your event to confirm that you reserved the designated picnic area.
